Effective Thursday 12:01 a.m., PDT, September 8, 2022

By virtue of the authority vested in me by ORS 477.625, ORS 477.670, and OAR 629-043-0070, I hereby issue notice the following subject area is susceptible to damage by fire and proclaim Industrial Fire Precaution Level 3 to be in effect:

All lands protected by the Coos Forest Protection District, in regulated use areas CS-2, CS-5, SK-1, and SK-2 and all forestland within one-eighth mile thereof.

Under Industrial Fire Precaution Level 3, the use of fire or power-driven machinery in any operation area is unlawful unless such use is in compliance with the following:

Restricted Shutdown: The following activities are not permitted at any time, except as noted:

- Cable yarding systems, except that gravity operated logging systems using non-motorized carriages or approved motorized carriages may operate between 8:00 p.m. and 1:00 p.m., when all blocks and moving lines are suspended at least 10 feet above the ground (except the line between the carriage and the chokers). An approved motorized carriage is defined as a cable yarding system employing a motorized carriage with two fire extinguishers, each with at least a 2A:10 BC rating, mounted securely on opposite sides of the carriage, an emergency motor cutoff, and an approved exhaust system.

The following are permitted to operate between the hours of 8 P.M. and 1 P.M.:

- Power saws at loading sites;
- Loading or hauling of any product or material;
- Blasting;
- Welding, cutting, or grinding of metal;
- Any other spark emitting operation not specifically mentioned.

In addition, the following are permitted to operate between the hours of 8 P.M. and 1 P.M. where mechanized equipment capable of constructing fire line is immediately available to quickly reach and effectively attack a fire start:

- Ground-based operations (tractor/skidder, feller-buncher, forwarder, or shovel logging operations);
- Power saws on ground-based operations;
- Rotary head saw feller-bunchers with a continuous Firewatch;
- Non-rotary head saw feller-bunchers;

- Tethered logging - winch-assisted, cable-assisted, traction-assisted, etc. systems, which enable ground-based timber harvesting machines to operate on steep slopes.

The State Forester or an authorized representative may, in writing, approve a modification or waiver of these requirements.

These restrictions shall remain in effect until replaced or terminated by an additional Closedown Order of the State Forester or an authorized representative.

Effective Friday 12:01 a.m., PDT, June 24, 2022

By virtue of the authority vested in me by ORS 477.505, I have determined conditions of fire hazard exist in the following subject area and declare Fire Season to be in effect:

All lands protected within the Coos Forest Protection Association District and all forestland within one-eighth mile there of CS-4, CS-5, SK-2.

The following acts are prohibited during fire season in accordance with ORS 477.510 and ORS 477.512:


- (1) Smoking while working in or traveling through any operation area.
- (2) The use of fuse and caps for blasting, unless approval is granted by the forester.
- (3) The discharge of an exploding target inside the district or within one-eighth mile of the district.
- (4) The discharge of tracer ammunition on land that is within the district or within one-eighth mile of the district, or when discharged, crosses above land that is within the district or within one-eighth mile of the district.

Unless prohibited by the forester, a permit is required for any open burning in accordance with ORS 477.515.

Additional fire restrictions or regulations may apply to various fire risks throughout the fire season.

Fire Season shall remain in effect until terminated by an additional declaration of the State Forester that conditions of fire hazard no longer exist.

By virtue of the authority vested in me by ORS 477.505, I have determined conditions of fire hazard exist in the following subject area and declare Fire Season to be in effect:

All lands protected within the Coos Forest Protection Association District and all forestland within one-eighth mile there of CS-1, CS-2, SK-1.

The following acts are prohibited during fire season in accordance with ORS 477.510 and ORS 477.512:


- (1) Smoking while working in or traveling through any operation area.
